

Town of New Hope Regular Board Meeting
Wednesday, July 19, 2017 – 7:00 p.m.

1. Call to order.

Dan Zaborowski called the meeting to order at 7:00 p.m. He opened the meeting leading us in the pledge of allegiance.

2. Review/Approval of minutes.

4. Five Corner Road reconstruction project.

Dan Zaborowski said the Town of Stockton provided an agreement for the Five Corner Road joint project with estimated costs and payment schedule. The Town's portion will be approximately \$17,500 this year for this project. 5. Road Improvement report.

Dan Zaborowski said grass cutting has begun. There were a few small trees down with the recent storms. Seal coating is complete by Scott Construction in the amount of \$34,366. Timm Raddatz noted a couple of areas of concern in the township.

6. Comprehensive Plan update.

Todd Knepfel said at the July 10 Plan Commission meeting they worked on the Town's zoning maps and they will continue to work on them at the next Plan Commission meeting on July 31, 2017 at 9:00 a.m. at the Portage County Planning and Zoning Department.

7. Recycling Events.

Timm Raddatz suggested Saturday, October 21, 2017 from 9:00 a.m. to 1:00 p.m. as the date for this year's recycling event. The same items will be accepted again this year with the possibility of adding tires on rims. Dan Zaborowski will contact Weller's to see if they will take tires with rims.

Timm Raddatz moved to pay the bills, seconded by Todd Knepfel. Ayes – all. Nays – none. Motion carried.
