#### 1. Call to order.

Chairman Knepfel called the meeting to order at 7:00 p.m. He opened the meeting leading us in the pledge of allegiance.

The cost of the culvert would be approximately \$1800 which would help with the water issue on her property. The water issues on her property were further discussed. Supervisor Zaborowski is concerned this will set a precedence if the Town installs the culvert. Chairman Knepfel suggested alternative options for Ms. Fechter. A meeting will be taking place shortly with the Department of Natural Resources regarding the flooding issues.

### 5. Fire Department report and 2020 Fire Department budget.

Chairman Knepfel said the fourth quarter assessment and 2% fire dues totals \$5,717.91. The lola Fire Department budget was reviewed. Their budget will be the same amount as it was this year.
