## 1. Call to order.

Chairman Knepfel called the meeting to order at 7:00 p.m. He opened the meeting leading us in the pledge of allegiance.

# 2. Review/Approval of minutes.

Supervisor Zaborowski expressed that he was up in the air because there were too many unanswered questions and he had concerns about traffic.

Chairman Knepfel stated that concerns had been raised regarding waste handling, water quality, emergency medical services and fire safety.

Resident Jessie Glodowski stated that there didn't seem to be a concrete plan for the campground. She checked and the land is advertised as being open to ATV use. Once permission is given how is it taken back.

Resident Jim McNight cited the Comprehensive Plan and the number of people brought in by the campground would be a negative input to the town.

Resident and County Board Supervisor Ray Reser said that he had talks to County Planning and Zoning staff and all the boxes need to be checked. First of all they have concerns that if it moves forward there would be no way to prevent campers from staying year around. Under the law campers are considered the same as mobile homes. Second, they are concerned about the ponds being treated with unknown chemicals, and third the property could be flipped in a few years and there would be no agreement with the new owners. Supervisor moved to accept the plan as presented for the campground at 2215 County Road A, Knepfel second. No votes for the motion, three nays. Motion failed.
