#### 1. Call to order.

Chairman Knepfel called the meeting to order at 7:00 p.m.

#### 2. Review/Approval of minutes.

# 4. Public Hearing –Amendment to the Comprehensive Plan to change a portion of land designation and zoning for parcel number 026-24-1007-15.02.

The Public Hearing was declared open. Chairman Knepfel reviewed the options with this land acquisition, land designation and zoning.

#### 5. Ordinance - Amend Town of New Hope Comprehensive Plan.

Supervisor Raddatz moved to approve the Ordinance to amend the Town of New Hope Comprehensive Plan. This amendment will change the land use designation on 10 acres of the 36.64 acre lot for parcel number 026-24-1007-15.02 from L2 General Ag to L3 Limited Ag/Mixed Use and the zoning for the same portion of parcel number 026-24-1007-15.02 from A1 Exclusive Agricultural District to A2 Agricultural Transition District. The zoning for the remaining portion of this parcel will be changed from A1 Exclusive Agricultural District to A20 Primary Agricultural District, seconded by Chairman Knepfel. Ayes: Knepfel, Raddatz and Zaborowski. Nays: None. Motion carried.

## 6. Ordinance Amendment – Controlling Dedication of Public Roads.

Chairman Knepfel stated updates were made to the ordinance and the penalty clause was eliminated. Supervisor Zaborowski moved to approve the Ordinance Amendment – Controlling Dedication of Public Roads, seconded by Timm Raddatz. Ayes – all. Nays – none. Motion carried.

#### 7. Road Improvement report.

Chairman Knepfel said Swenson Tree Service will take care of the additional brushing and tree trimming that was approved by the Board in February using some of the additional funds that the Town was awarded.

## 8. Town of New Hope Action Survey.

Chairman Knepfel provided a survey to the Board, Clerk and Treasurer for them to review and rate the importance of the items listed.
