

Town of New Hope Regular Board Meeting
Wednesday, July 15, 2020 – 7:00 p.m.
Town Hall, 9785 Town Hall Road

Members present: Chairman Knepfel, Supervisor Raddatz and Supervisor Zaborowski
Also Present: Kari Yenter, Dorene Stolpa and Nick Achtermeier

1. Call to order.

Chairman Knepfel called the meeting to order at 7:00 p.m. He opened the meeting leading us in the pledge of allegiance.

2. Review/Approval of minutes.

The minutes of the last monthly meeting were read by Clerk Yenter. Supervisor Raddatz moved to approve the minutes, seconded by Supervisor Zaborowski. Ayes – all. Nays – none. Motion carried.

3. Persons who wish to address the Board.

Nick Achtermeier, Harter's Fox Valley Disposal, said their main base is in Wittenberg. They service approximately 80 municipalities. Garbage is collected weekly and recycling is collected biweekly. Each household would be provided with two 95-gallon carts, one for trash and the other for recycling. Large item pickup is available at an additional cost to the resident. The Town of New Hope would be billed monthly for these services.

4. Road Improvement report.

Chairman Knepfel said the board members met with Deputy Weed Commissioner Pete Arntsen to examine Japanese Knotweed growing along Grayson Road. Sunset Lake water level has increased. Minister Lake and Skunk Lake water levels are lower than Sunset Lake. There is an old culvert by the boat land at Sunset Lake that is not working. Sunset Lake Road was dedicated in 1909 and it was paved in the 1950's. The Chairman said the crack filling, seal coating and wedging projects are complete. Tree trimming and brushing still needs to be completed.

5. Recycling Event.

Supervisor Raddatz called Wellers Salvage for prices but no one has contacted him back yet.

6. Partisan Primary Election.

Supervisor Raddatz said the church is asking that the Town of New Hope pay to have the church cleaned and sanitized after elections. Supervisor Zaborowski moved to approve three poll workers for the Partisan Primary Election on August 11, 2020, seconded by Supervisor Raddatz. Ayes – all. Nays – none. Motion carried.

7. Payment of bills.

Supervisor Raddatz moved to pay the bills, seconded by Supervisor Zaborowski. Ayes – all. Nays – none. Motion carried. Supervisor Zaborowski moved to pay Tony Kostuch

\$100.00 for tree removal services and grass cutting, seconded by Supervisor Raddatz. Ayes – all. Nays – none. Motion carried.

8. Set date for next Board Meeting.

The next regular Town of New Hope Board meeting will be held on Wednesday, August 19, 2020 at 7:00 p.m. at the Town Hall.

9. Adjournment.
